Mr. Paris has conducted over 1,200 failure and fire analysis projects related to residential, commercial, industrial, and utility electrical power systems, as well as various electrical equipment and devices, including refrigeration and HVAC, household appliances, electronics, batteries, electrical motors, transformers, control equipment, wiring, lighting fixtures/lamps, AC/DC drive systems, and vehicle electrical systems.
